Dr. Neville A. Gallimore **Director of IT Management and Oversight** **Directorate**

Dr. Neville A. Gallimore is the agency's director of the IT management and oversight directorate, responsible for directing major systems program development, policy development, cyber security strategy, enterprise architecture planning and design supervision, capital planning and investment control, portfolio management, and information technology workforce development. He also leads long-range planning and budgeting efforts for major IT implementation tasks. He is responsible for and overseeing DeCA's IT budget, encompassing global wide geographically located commissaries.

Dr. Gallimore ensures appropriate cybersecurity policies and procedures for cybersecurity and computer network defense, ensuring compliance with statutes and established policy and reporting requirements. He manages a strong cybersecurity posture by supervising the cybersecurity branch in their mission of; assessing security controls, certifying PCI compliance, and DoD security task orders on enterprise system platforms and networks.

Dr. Gallimore also provides oversight of IT workforce planning and certification. He directs the execution of records management and knowledge management programs, consistently improving information collection processes, paperwork reduction, and E-government initiatives. He represents the agency as a senior subject matter expert and spokesperson on IT matters with the Defense Department, military services, Office of Management and Budget (OMB), other executive agencies, and industry partners.

Dr. Gallimore assumed the position of director of the management and oversight directorate in 2020 after serving as program chief of management and oversight division since 2017.

He came to DeCA in 2017 after serving with the U.S. Army Corps of Engineers (USACE) St. Louis, Missouri District, as its IT chief responsible for providing expert technical IT and analytical advice and guidance to the district commander and staff, division commander and staff, ACE-IT director and staff, chief information officer and staff plus major subordinate commands/separate reporting activities. He was responsible for \$2 million IT infrastructure budget and associated C4IM systems portfolio management, using the electronic CPIC portfolio management system (eCPIC).

On several occasions, Dr. Gallimore performed duties of the Mississippi Valley Division IT chief, supervising five GS14 and six GS13 IT specialists. Toward the end of his tenure, he was dual-hatted as the IT program manager for the entire U.S. Army Corps of Engineers' enterprise planning program (P2), used to manage and track the status of the approximately \$40 billion budget and major programs portfolio status for all USACE military and civil works missions; intercoastal water ways management, federal power plants, locks and dams, federal land management, federal construction, real estate and right-of-way permitting, SuperFund site management, flood, and water quality management programs.

Dr. Gallimore has over 37 years of experience managing IT systems solutions; designing, securing, and supporting IT enterprise services in private industry, tactical, and strategic DoD computing environments, throughout systems lifecycle. He is certified in multiple information technology, program management, and cybersecurity domains.
