NOTICE TO THE TRADE – DeCA NOTICE 26-23

SUBJECT: Store Reset Schedule FY26 – Updated with Minor Changes

The purpose of this “Notice to the Trade” is to alert all concerned refer to NTT 26-04 ‘Store Reset Schedule FY26’ to address with updated information that included removal of Patrick SFB from the reset schedule. Patrick SFB will be replaced with Fort Worth, and the dates will remain the same, starting on June 6, 2026.

The Dover AFB Perishable Reset will be rescheduled from May to April 19 to 21<sup>st</sup> in the new reset schedule. Please accept our apologies for any inconvenience this may cause. Any further information or guidance will be announced with as much advance notice as possible for future planning purposes.

**For your refresh from NTT 26-04:** This schedule is very aggressive but addresses many of the stores with shelving and flow concerns. It is essential to note that contract issues persist with shelving manufacturers, and labor shortages persist among installers. With those issues being a primary concern, along with any unforeseen issues that occur throughout the FY, this schedule is subject to change.

Additionally, we would like to inform stakeholders that we will continue to reset stores after normal business hours. This minimizes disruption to patrons. The current model adds layers to scheduling because each store requires specific days to be allocated.

As a gentle reminder, to complete this aggressive schedule, vendor support will be crucial. As we approach the reset dates, an additional store-specific NTT will be disseminated to include the reset timeline, set-up information, and required delivery dates for vendor-supplied equipment. Your support is greatly appreciated.

The Perishable Consumables and Produce teams will also work in conjunction with stores to right-size categories, improve flow, and enhance the overall footprint as needed or when the opportunity arises. These resets will be identified on the attached schedule, but may also be conducted independently to address stores that require attention.
