# Michelyne C. LeBlanc Deputy to the Executive Director and Chief Information Officer, Information Technology Group

Ms. Michelyne LeBlanc is the Deputy to the Executive Director and Chief Information Officer (CIO), Information Technology Group, for the Defense Commissary Agency, headquartered at Fort Lee, Va.

In this position, Ms. LeBlanc serves as the principal advisor to the Executive Director, a Senior Executive Service (SES) member for the DeCA IT Group policies, plans, programs, and procedures, and delivery of reliable, efficient, and productivity-enhancing IT services for DeCA as well as customers throughout the rest of DoD, other Federal and allied government agencies, and industry. She is also accountable to the Executive Director for being an effective change agent in the implementation and coordination of the overall enterprise architecture, including applications and programs integration, cloud migration, system engineering, data maturity, business process reform, and compliance with Federal and Department of Defense policies and requirements. This selection was effective July 2021.



As Deputy to the CIO, Ms. LeBlanc is responsible for assessing current and future IT Group innovation initiatives, program management, and technology trends in software intensive systems. She also advises the executive director on cloud solutions and open enterprise architectures and methodologies. She provides broad agency planning leadership and guidance to IT managers and specialists for critical projects and programs as designated by the executive director to ensure IT integrity and consistency with corporate objectives.

She is responsible for planning and execution of information technology investments and manages the agency's information assurance architecture for the worldwide commissary system. She also manages and directs DeCA's IT functions for the agency's headquarters elements and nearly 240 commissaries configured under five areas divided into 26 field zones in 46 states, 13 countries and two U.S. territories.

Ms. LeBlanc has served in two separate assignments as Acting Executive Director and Chief Information Officer (CIO), Information Technology Group: first from May 1, 2023, to January 13, 2024, and again from June 2 to November 2025. In this position she was responsible for planning and execution of information technology investments and managed the agency's information assurance architecture.

Before joining DeCA, Ms. LeBlanc served as the chief enterprise architect for the Defense Contract Management Agency (DCMA), responsible for developing technology strategies, principles, and roadmaps in alignment with business strategies and objectives. She helped institute an agency capability model as the foundation for driving technology modernization based on agency business processes. Prior to joining DCMA, Ms. LeBlanc was the lead architect for the Army Integrated Logistics Architecture (AILA). The AILA served as the Army's designated and overarching logistics architecture of record providing the means to move and translate data from multiple sources into a meaningful logistics common operating picture.

Ms. LeBlanc is a military veteran who served 6 years in the U.S. Army. She has over 20 years of experience supporting the Department of Defense from both the government and private sectors.
