### Oscar G. Rodriguez Chief Financial Officer



Oscar G. Rodriguez is the Chief Financial Officer (CFO) for the Defense Commissary Agency (DeCA), headquartered at Fort Lee, Virginia. He directs the full scope of the agency's global financial management, overseeing budget formulation and execution, accounting operations, and strategic resource planning to support DeCA's worldwide mission. This includes budget oversight that exceeds \$4.8 billion in DeCA resale funds, \$1.5 billion in operating funds and \$297 million in commissary surcharge funds, annually.

DeCA has more than 12,000 employees serving in a headquarters and five area offices supporting 234 commissaries located in 13 countries worldwide.

As CFO, Mr. Rodriguez provides executive financial leadership for a global organization, ensuring the sound stewardship of both appropriated and non-appropriated funds. His oversight aligns DeCA's financial strategy with its operational readiness and customer service goals, managing multi-billion-dollar budgets, enterprise-wide financial reporting, and strict compliance with federal and Department of Defense regulations.

Mr. Rodriguez's career is marked by a series of senior executive roles across the Department of Defense and the Department of Veterans Affairs. He has served as Acting Executive Director (CEO), Deputy Executive Director (SES) for two high-complexity VA Health Care System and has held multiple CFO and Director of Resource Management positions in defense, healthcare, and logistics. His leadership has been instrumental in driving major initiatives in audit remediation, strengthening internal controls, and modernizing enterprise financial systems.

A retired U.S. Army officer, Mr. Rodriguez brings a legacy of disciplined leadership and mission-focused execution to his role. He has a distinguished track record of building high-performing teams and enhancing fiscal accountability within complex, high-reliability organizations.
