Rosie Leonard-Greer Chief Financial Officer

Rosie Leonard-Greer is the Chief Financial Officer for the Defense Commissary Agency, headquartered at Fort Lee, Virginia. Ms. Leonard-Greer is responsible for all financial aspects of the agency's retail sales and operating budgets. This includes budget oversight that exceeds \$4.6 billion in DeCA resale funds, \$1.4 billion in operating funds and \$297 million in commissary surcharge funds, annually.

Her selection was effective April 19, 2026. Ms. Leonard-Greer had served as acting Chief Financial Officer from August 2025 to March 2026.

As CFO, Ms. Leonard-Greer provides executive financial leadership for a global organization of 12,000 employees serving in a headquarters and five area offices supporting 235 commissaries located in 13 countries worldwide. Her oversight ensures the agency's sound stewardship of both appropriated and non-appropriated funds.

Ms. Leonard-Greer is responsible for aligning DeCA's financial strategy with its operational readiness and customer service goals, managing multi-billion-dollar budgets, enterprise-wide financial reporting, and strict compliance with federal and Department of War regulations. She also serves as the agency liaison with the Office, Secretary of War, Comptroller's Office and the Defense Finance and Accounting Services.

Ms. Leonard-Greer previously served as Accounting Director where she managed the agency's accounting processes, analysis, and financial accounting activities. Before that assignment she worked as the Chief of the Financial Liaison Branch, where she managed the agency payroll, non-resale accounting and travel processes. She has over 30 years of experience within the financial management community.
